State law requires account balances to be surrendered or escheated to the State of California if the owner has not generated any account activity within three years.

Accounts with no activity for at least 3 years are considered dormant and will be subject to a \$5.00 per month fee. A simple transaction will avoid accounts from being feed or surrendered. Please contact a
