Dormant Accounts

Mokelumne Federal Credit Union would like to make you aware: If your account has not experienced activity for at least 12 months, it is classified as dormant or inactive.

Dormant / inactive accounts are subject to a \$5.00 per month fee. You can easily reactivate your account and avoid this fee by making any kind of transaction to your account.

State law requires account balances be surrendered or escheated to the State of California if the owner has not generated account activity within three years.

To avoid this, we encourage you to take action as soon as possible. Please contact a branch nearest you to assist in protecting your funds.
